REQUESTED ACTION

That approval be and hereby is given to the Attorney General to reappoint Bryan J. Townsend, II, as an Assistant Attorney General (Position #9U047, Appropriation #02-20-20-200510-2611-013-500132), at a salary level of \$92,000 upon Governor and Executive Council approval, or December 11, 2022, whichever is later, for a term ending December 11, 2027.

EXPLANATION

Mr. Townsend is a resident of Merrimack and a member of the New Hampshire Bar. He earned his undergraduate degree, cum laude, from the University of New Hampshire in 2007 and his Juris Doctor from the University of New Hampshire School of Law in 2010. While in law school, he was selected as a member of the Daniel Webster Scholar Honors Program. Following graduation, he served as a judicial law clerk at the New Hampshire Supreme Court from 2010 to 2012. He worked as an associate attorney at Gottesman and Hollis from 2012 to 2016 at which time he joined the Department's Criminal Justice Bureau. After three years in the Medicaid Fraud Control Unit, he was assigned as the Elder Abuse Prosecutor in the Consumer Protection/Anti-Trust Bureau. He was designated a Senior Assistant Attorney General on February 9, 2022. This reappointment gives Mr. Townsend another five-year term. His salary will remain the same and I will continue his current assignment. His resume is attached for your review.

RSA 21-M:3 and 94:1-a(I)(c) provide that designation of positions, salary levels, and salary increases for attorneys at the Department of Justice shall be determined by the Attorney General, subject to approval of the Governor and Council, within appropriations made to the Department of Justice.
