#### REQUESTED ACTION

Authorize the New Hampshire Department of Energy (NHDOE) to enter into a grant agreement with Berlin School District (VC 177267), Berlin, NH, in the amount of \$150,000 for the implementation of energy efficiency projects and upgrades, effective upon Governor and Executive Council approval, through June 30, 2023.

#### **EXPLANATION**

NHDOE respectfully requests authority to enter into a grant agreement in an amount not to exceed \$150,000 with Berlin School District to support Berlin Middle High School's objectives to promote energy use reduction, responsible energy behavior within their school, allow necessary energy efficiency upgrades, and other initiatives approved by NHDOE. The project being undertaken is upgrading the interior lighting throughout the entirety of Berlin Middle High School to new LEDs. This project will be administered by Berlin Middle High School.

NHDOE issued a Notice of Funding Availability (NOFA) on May 18, 2022 for the School Energy Efficiency Development (SEED) Grant Program, a competitive grant program open to public schools to fund energy efficiency projects. Applications for the NOFA were accepted until the NOFA closed on July 20, 2022. NHDOE received eight applications that were reviewed and scored by an Evaluation Team made up of five State employees. The scoring sheet is attached.

In the event Federal Funds are no longer available, General Funds will not be requested to support this program.

SCOPE OF WORK: In exchange for grant funds provided by the State of New Hampshire, acting through the Agency identified in block 1.1 (hereinafter referred to as "the State"), the Grantee identified in block 1.3 (hereinafter referred to as "the Grantee"), shall perform that work identified and more particularly described in the scope of work attached hereto as EXHIBIT B (the scope of work being hereinafter referred to as "the Project").

AREA COVERED. Except as otherwise specifically provided for herein, the Grantee shall perform the Project in, and with respect to, the State of New Hampshire.

EFFECTIVE DATE: COMPLETION OF PROJECT.

- Except as otherwise specifically provided herein, the Project, including all 9.4. reports required by this Agreement, shall be completed in ITS entirety prior to the date in block 1.7 (hereinafter referred to as "the Completion Date").
- **GRANT AMOUNT: LIMITATION ON AMOUNT: VOUCHERS: PAYMENT**
- The Grant Amount is identified and more particularly described in EXHIBIT C, attached hereto.
- The manner of, and schedule of payment shall be as set forth in EXHIBIT C.
- 5.3. In accordance with the provisions set forth in EXHIBIT C, and in consideration 10. of the satisfactory performance of the Project, as determined by the State, and as limited by subparagraph 5.5 of these general provisions, the State shall pay the Grantee the Grant Amount. The State shall withhold from the amount otherwise payable to the Grantee under this subparagraph 5.3 those sums required, or permitted, to be withheld pursuant to N.H. RSA 80:7 through 7-c.
- The payment by the State of the Grant amount shall be the only, and the complete payment to the Grantee for all expenses, of whatever nature, incurred by the Grantee in the performance hereof, and shall be the only, and the complete, compensation to the Grantee for the Project. The State shall have no 11. liabilities to the Grantee other than the Grant Amount.

- COMPLIANCE BY GRANTEE WITH LAWS AND REGULATIONS. RECORDS and ACCOUNTS.

- Between the Effective Date and the date seven (7) years after the Completion Date, unless otherwise required by the grant terms or the Agency, the Grantee shall keep detailed accounts of all expenses incurred in connection with the 11.2.2 Project, including, but not limited to, costs of administration, transportation, insurance, telephone calls, and clerical materials and services. Such accounts shall be supported by receipts, invoices, bills and other similar documents.

and authorized to perform such Project under all applicable laws. The Grantee shall not hire, and it shall not permit any subcontractor, subgrantee, or other person, firm or corporation with whom it is engaged in a combined effort to perform the Project, to hire any person who has a contractual

The Grant Officer shall be the representative of the State hereunder. In the event of any dispute hereunder, the interpretation of this Agreement by the Grant

DATA; RETENTION OF DATA; ACCESS.

As used in this Agreement, the word "data" shall mean all information and things developed or obtained during the performance of, or acquired or developed by reason of, this Agreement, including, but not limited to, all studies, reports, files, formulae, surveys, maps, charts, sound recordings, video recordings, pictorial reproductions, drawings, analyses, graphic representations,

computer programs, computer printouts, notes, letters, memoranda, paper, and documents, all whether finished or unfinished.

Between the Effective Date and the Completion Date the Grantee shall grant to the State, or any person designated by it, unrestricted access to all data for examination, duplication, publication, translation, sale, disposal, or for any other purpose whatsoever.

No data shall be subject to copyright in the United States or any other country by anyone other than the State.

On and after the Effective Date all data, and any property which has been received from the State or purchased with funds provided for that purpose under this Agreement, shall be the property of the State, and shall be returned to the State upon demand or upon termination of this Agreement for any reason, whichever shall first occur.

The State, and anyone it shall designate, shall have unrestricted authority to publish, disclose, distribute and otherwise use, in whole or in part, all data

CONDITIONAL NATURE OR AGREEMENT. Notwithstanding anything in this Agreement to the contrary, all obligations of the State hereunder, including, without limitation, the continuance of payments hereunder, are contingent upon the availability or continued appropriation of funds, and in no event shall the State be liable for any payments hereunder in excess of such available or appropriated funds. In the event of a reduction or termination of those funds, the State shall have the right to withhold payment until such funds become available, if ever, and shall have the right to terminate this Agreement immediately upon giving the Grantee notice of such termination.

EVENT OF DEFAULT: REMEDIES.

No express waiver of any Event of Default shall be deemed a waiver of any provisions hereof. No such failure of waiver shall be deemed a waiver of the right of the State to enforce each and all of the provisions hereof upon any further or other default on the part of the Grantee

NOTICE. Any notice by a party hereto to the other party shall be deemed to have been duly delivered or given at the time of mailing by certified mail, postage prepaid, in a United States Post Office addressed to the parties at the addresses first above given.

AMENDMENT. This Agreement may be amended, waived or discharged only by an instrument in writing signed by the parties hereto and only after approval of such amendment, waiver or discharge by the Governor and Council of the State of New Hampshire, if required or by the signing State Agency.

CONSTRUCTION OF AGREEMENT AND TERMS. This Agreement shall be construed in accordance with the law of the State of New Hampshire, and is binding upon and inures to the benefit of the parties and their respective successors and assignees. The captions and contents of the "subject" blank are used only as a matter of convenience, and are not to be considered a part of this Agreement or to be used in determining the intend of the parties hereto.

THIRD PARTIES. The parties hereto do not intend to benefit any third parties and this Agreement shall not be construed to confer any such benefit.

ENTIRE AGREEMENT. This Agreement, which may be executed in a number of counterparts, each of which shall be deemed an original, constitutes the entire agreement and understanding between the parties, and supersedes all prior agreements and understandings relating hereto.

SPECIAL PROVISIONS. The additional or modifying provisions set forth in Exhibit A hereto are incorporated as part of this agreement.

#### SPECIAL PROVISIONS

The New Hampshire Department of Energy (NHDOE) reserves the right to use any legal remedy at its disposal including, but not limited to, disallowance of costs, withholding of funds, suspension of agency personnel, disbarment of agency personnel, disbarment of agencies and/or subcontractors from present or future contracts, and such other legal remedies as determined to be appropriate by the New Hampshire Department of Justice in the enforcement of rules and regulations pertaining to the State Energy Program.
- An audit shall be made at the end of the Grantee's fiscal year in accordance with 2 CFR 200, Subpart
  F Audit Requirements. This audit report shall include a schedule of revenues and expenditures by
  contract or grant number of all expenditures during the Grantee's fiscal year.

The audit report shall include a schedule of prior year's questioned costs along with a response to the current status of the prior year's questioned costs. Copies of all management letters written as a result of the audit along with the audit report shall be forwarded to NHDOE within one month of the time of receipt by the Grantee accompanied by an action plan, if applicable, for each finding or questioned cost.

- 3. The costs charged under this contract shall be determined as allowable under the cost principles detailed in 2 CFR 200 Subpart E Cost Principles.
- 4. Program and financial records pertaining to this contract shall be retained by the Grantee for 3 (three) years from the date of submission of the final expenditure report or, for awards that are renewed quarterly or annually, from the date of the submission of the quarterly or annual financial report, as stated in 2 CFR 200.334-338 Retention Requirements for Records.
- The NHDOE shall have the right to issue periodic notices, memos, and updated reporting forms and information.
- Grantee shall notify NHDOE of any media inquiries and responses and copies of published media clippings and broadcasts. The NHDOE shall have the right to participate in any meetings with media.
- 7. NHDOE shall have the right to publicize progress of this program.
- 8. Griffin Roberge, State Program Manager of NHDOE, has been designated with the responsibility for overseeing this contract.
- 9. RESTRICTION ON ADDITIONAL FUNDING. It is understood and agreed between the parties that no portion of the "Grant" funds may be used for the purpose of obtaining additional Federal funds under any other law of the United States, except if authorized under that law."

#### **EXHIBIT B**

#### SCOPE OF SERVICES

- A. Berlin School District hereinafter "the Grantee," agrees to provide services to implement the School Energy Efficiency Development (SEED) Grant as detailed in the scope of work.
- B. The contract period will commence upon the approval of Governor and Executive Council, approval of final budget by the New Hampshire Department of Energy (NHDOE) and will have a completion date of June 30, 2023. All funds must be expended by June 30, 2023. NHDOE at any time, in its sole discretion, may terminate the contract or postpone or delay all or any part of this contract, upon written notice.

#### Scope of Work:

- 1. Each energy efficiency measure is described below in detail:
