### REQUESTED ACTION

Pursuant to RSA 94:6, the Department of Health and Human Services respectfully requests to place Jill Burke at Step 5 for the position of Bureau Chief, Bureau of Drug and Alcohol Services, Division for Behavioral Health, Position #9U432, unclassified salary grade FF, earning \$102,160.00 effective August 25, 2023, upon Governor and Council approval. 47.4% General Funds and 52.6% Federal Funds.

### **EXPLANATION**

The Bureau Chief for the Bureau of Drug and Alcohol Services provides leadership and planning, programmatic oversight and operational direction for statewide programs and staff for the bureau, which is responsible for administering programs and services for New Hampshire residents with substance misuse challenges. This position directs the implementation, integration, and coordination of all Bureau of Drug and Alcohol programs and activities, initiatives, and contracted services, ensuring compliance with agency and federal requirements. It also requires close coordination and integration with other Division bureaus and across the Department.

Based on her educational background, experience and demonstrated skills Ms. Burke is well qualified to direct and implement strategies for the operations and development of the bureau chief role.

Ms. Burke has 25 years of public health and policy experience, serving the last nine years in the Bureau of Drug and Alcohol Services. She holds a Master of Public Administration from the University of New Hampshire and bachelor's degree in political science from Keuka College, NY.

Ms. Burke's experience in the public sector as well as in overseeing the prevention, treatment and recovery programs for the Department supports this request for appointment at Step 5.

I respectfully request that Ms. Burke be placed in the position of Bureau Chief, Bureau of Drug and Alcohol Services, Division for Behavioral Health, unclassified salary grade FF, at step 5 with and effective start date of August 25, 2023.
