REQUESTED ACTION

Pursuant to RSA: 94:6 the Department of Health and Human Services respectfully requests to place Dr. Alexandra E. Caron at Step 4 for the position of Pharmacist – Inpatient Mental Health System of NH, position #9U561, unclassified salary grade KK, earning \$130,216.00 effective September 8, 2023, upon Governor and Council approval. 85% General Funds, 15% Other (interagency).

EXPLANATION

Position #9U561, Pharmacist, Inpatient Mental Health System of New Hampshire for the Department of Health and Human Services (DHHS), is responsible to oversee pharmacy technicians, dispense medications, supply medical literature to and counsel patients upon discharge. Also, the Pharmacist provides responsible professional work in the receipt and storage of medicinal and other pharmaceutical supplies. The Pharmacist gives direction to and consults with unit team members, as well as compiles, analyzes, and interprets data for quality assurance projects. In addition, the Pharmacist participates on various professional committees at New Hampshire Hospital, and in a rotating on call schedule.

Dr. Caron earned a Doctorate of Pharmacy from the MCPHS University in 2021. Prior to graduation, she completed an internship at New Hampshire Hospital Pharmacy, where she showed a strong aptitude for clinical pharmaceutical care of mental health patients. In her current role as a hospital clinical pharmacist, Dr. Caron has gained experience in all of the tasks that are essential for success as a New Hampshire Hospital Pharmacist. In particular, Dr. Caron has expertise in medication reconciliation, working in collaboration with teams on units, in writing pharmacy consults, and giving oral presentations.

Although it is not the goal for government to compete with private industry, DHHS' goal is to recruit and hire quality, experienced employees to enable the Department to provide services to the citizens of New Hampshire effectively and efficiently. The hiring landscape supports appointment at Step 4. I respectfully request that Dr. Caron be placed in the Pharmacist – Inpatient Mental Health System of NH position.
