#### REQUESTED ACTION

Pursuant to RSA 198:15-y, III, I respectfully request approval to **retroactively** amend expenditure authorization in the amount of \$9,882,155.40 for school security improvement projects by extending the end date from June 30, 2023 to June 30, 2024. Item was originally approved by Fiscal Committee on November 18, 2022 (Item #FIS 22-380) and Executive Council on November 22, 2022 (Item #53), and amended by Fiscal Committee on May 19, 2023 (Item #FIS 23-164) and Executive Council on May 17, 2023 (Item #39), effective upon Fiscal Committee and Governor and Council approval. 100% Federal Funds.

### **EXPLANATION**

This item is **retroactive** due to the request needing to be held until the new Fiscal Year, when the Fiscal Committee would then have the authority to approve items for the FY24-25 biennium. The funding the New Hampshire Department of Education (NHED) received from American Rescue Plan Act (ARPA) State Fiscal Recovery Fund (SFRF), which is used to facilitate, award, and administer the Security Action for Education (SAFE) grant awards, does not expire until December 31, 2026. The original accept and expend item was approved through June 30, 2023, as the request was only able to be submitted through the end of the FY22-23 biennium at that time.

The New Hampshire Department of Education (NHED), Bureau of School Safety and Facility Management, received the \$10,260,000 in ARPA SFRF funds through the Governor's Office for Emergency Relief and Recovery (GOFERR). The GOFERR award was approved by Fiscal Committee on June 17, 2022, and Governor and Council on June 29, 2022; and extended by Fiscal Committee on May 19, 2023 and Governor and Council on May 31, 2023. This funding was to be granted to NH public and nonpublic schools for security improvement projects utilizing the Public School Infrastructure Fund process established in FY2018.

RSA 198:15-y created the Public School Infrastructure Commission and the Public School Infrastructure Fund with the purpose of providing funding for infrastructure projects for public elementary and secondary schools. The law allows for several categories of projects to be eligible for aid through the Public School Infrastructure Fund. One such category is "funding for the department of safety, division of homeland security and emergency management's school emergency readiness program to improve security in public schools, after the completion of a security assessment, and in consultation with municipal officials."

With the intent of improving security in NH schools, the Public School Infrastructure Commission developed and approved a Security Action for Education (SAFE) grant application that public and nonpublic schools could use to apply for grant funds for eligible projects. The Commission agreed upon three general project categories that would be eligible for SAFE grant funding. These categories are access control, surveillance, and emergency alerting. In order for a project to be eligible for funding, the proposed activity was required to fall under one of these three categories. Eligible projects were capped at \$100,000 per school.

Schools submitted applications to the Commission through the Homeland Security and Emergency Management's (HSEM) School Resource Center. HSEM then risk ranked all projects, which resulted in 335 applications from 249 unique schools (231 public, and 18 nonpublic).

These SAFE grant recipients have until December 31, 2024 to expend all funds and complete all approved project activities. As of this request, \$8,208,858.83 of the approved grant funding is pending expenditure, and all approved projects remain open and active. NHED will assess approved projects and expenditures in the spring of 2024 to determine if additional extension requests need to be submitted to the Fiscal Committee and Governor and Council.

Approval of this extension will allow NHED to continue to reimburse New Hampshire public and non-public schools for the school security improvement grant awards previously approved by Fiscal Committee and Governor and Executive Council.

In the event that Federal Funds become no longer available, General Funds will not be requested to support these programs.

#### EXPLANATION

The New Hampshire Department of Education (NHED), Bureau of School Safety and Facility Management, received \$10,260,000 from the American Rescue Plan Act (ARPA) State Fiscal Recovery Fund (SFRF) through the Governor's Office for Emergency Relief and Recovery (GOFERR), The GOFERR award was approved by Fiscal Committee on June 17, 2022, and Governor and Council on June 29, 2022. This funding was to be granted to NH public and nonpublic schools for security improvement projects utilizing the Public School Infrastructure Pund process established in FY2018.

The Public School Infrastructure Commission developed and approved a Security Action for Education (SAFE) grant application whereby NH public and nonpublic schools could apply for grant funding through the funds received from GOFERR to improve school security. In order for a project to be eligible for

funding, the proposed activity was required to fall under one of three categories: access control, surveillance, and emergency alerting.

Schools submitted applications to the Commission through the Homeland Security and Emergency Management's (HSEM's) portal, and HSEM then ranked the submitted applications based on a risk assessment. HSEM's ranked list was approved for funding at Fiscal Committee on November 18, 2022 (Item #FIS 22-380) and Executive Council on November 22, 2022 (Item #53).

Subsequently, Windham School District submitted a request to the Public School Infrastructure Commission to increase the total SAFE grant funding awarded to their three schools by an additional \$8,550. This request explained that the district realized an error had been made in the SAFE grant applications for Golden Brook School, Windham Center School, and Windham Middle School which had gone unrecognized until after approval. Some proposed activities submitted under Golden Brook School's application were instead intended to be spread across all three school applications. The district further explained that the cost to complete the project has also increased. Therefore, the district requested \$8,550 in additional SAFB grant funding to both address the errors made in the submitted applications and the increase in project cost.

The Public School Infrastructure Commission reviewed and approved Windham School District's request for increased SAFE grant funding for the three schools. Having consulted with the Commission, I am requesting authorization to amend the grant limitations for Golden Brook School from \$63,035 to \$40,985, Windham Center School from \$16,055 to \$31,355, and Windham Middle School from \$13,146 to \$28,446.

#### **EXPLANATION**

The New Hampshire Department of Education (NHED), Bureau of School Safety and Facility Management, received \$10,260,000 from the American Rescue Plan Act (ARPA) State Fiscal Recovery Fund (SFRF) through the Governor's Office for Emergency Relief and Recovery (GOFERR). The GOFERR award was approved by Fiscal Committee on June 17, 2022, and Governor and Council on June 29, 2022. This funding was to be granted to NH public and nonpublic schools for security improvement projects utilizing the Public School Infrastructure Fund process established in FY2018.

RSA 198:15-y created the Public School Infrastructure Commission and the Public School Infrastructure Fund with the purpose of providing funding for infrastructure projects for public elementary and secondary schools. control, surveillance, and emergency alerting. In order for a project to be eligible for funding, the proposed activity was required to fall under one of these three categories. Eligible projects were capped at \$100,000 per school.

Schools submitted applications to the Commission through the Homeland Security and Emergency Management's (HSEM) School Resource Center, and HSEM then reviewed the submitted applications to assess potential risk based on a scoring rubric with five questions which were included as part of the application. The results of scoring rubric indicated the lower the score, the higher the risk. The highest potential score was a 7.0, and the average score was 5.8.

These federally funded GOFERR grants constitute a second round of SAFE grants to NH schools, with a first round of grants being recently awarded to public schools from the Public School Infrastructure Fund. Schools that submitted applications for the first round of grants and did not receive an award were automatically reconsidered when HSEM conducted the ranking for the second round.

In accordance with the NHED grant proposal approved by GOFERR, applications that fell in approved risk categories were considered for this round of funding. HSEM risk ranked all projects, which resulted in 335 applications from 249 unique schools (231 public, and 18 nonpublic) recommended for funding. The Commission reviewed and approved the HSEM ranking and project funding recommendations. Having consulted with the Commission, I am requesting authorization to expend funds for the attached list of projects.
