REQUESTED ACTION

Pursuant to RSA 14:30-a, VI, authorize the Department of Environmental Services (NHDES) to accept and expend \$500,000 in Drinking Water and Groundwater Trust Funds to continue to provide financial assistance to low-income New Hampshire homeowners with residential wells experiencing irreversible water supply or quality problems due to natural disasters, effective upon Fiscal Committee and Governor and Council approval through June 30, 2025. 100% Drinking Water and Groundwater Trust Fund.

Funding is to be appropriated as follows:

EXPLANATION

We are requesting approval of this fiscal request to fulfill obligations to low-income homeowners approved for the program before June 30, 2023 with reimbursements pending completion of the well installation. On February 14, 2022, the Drinking Water and Groundwater Trust Fund (DWGTF) Advisory Commission (Commission) awarded \$500,000 to NHDES for the Water Assistance for Natural Disaster Impacts to Low-Income Residential Well Owners program (WAND). In response to the high demand for the program, the Commission awarded an additional \$750,000 to NHDES on September 26, 2022, for a total of \$1,250,000 to continue the WAND program. The WAND program provides financial assistance, in the form of reimbursements, for qualifying low-income New Hampshire homeowners served by residential wells that are experiencing irreversible water quantity or quality problems due to extreme weather events or natural hazards, such as flooding and drought. Qualifying homeowners may receive financial assistance from the WAND program to repair or replace the compromised well.

Since initiation of the program in August 2022, NHDES has approved 57 low-income homeowners for financial assistance to replace residential wells that have failed due to drought. There are currently 29 homeowners that have been approved for the program based on irreversible water supply issues and household income. We are requesting approval of this increase because there was insufficient time to process the financial review and complete the work before June 30, 2023 and the FY24 operating budget did not anticipate needing this level of funding. Despite the heavy

rainfall experienced in New Hampshire in recent weeks, the homeowners in this program have wells located in areas with inadequate groundwater recovery and have been confirmed by a certified well driller to be irrecoverable. These funds will also allow NHDES to keep the program open for qualifying low-income households that experience a natural disaster that impacts their well and access to safe drinking water.

NHDES is requesting to budget these additional funds as shown below:

Class 300

To reimburse costs incurred by eligible homeowners whose wells have experienced irreversible water supply quantity or water quality problems for remedies to include, but not limited to, a temporary auxiliary storage tank and bulk water, increasing supply capacity, increasing storage capacity, lowering an existing well pump, deepening an existing well, installing a replacement well, and water quality sampling and treatment of the deepened/replacement well.

We respectfully request your approval.
