# REQUESTED ACTION

Pursuant to RSA 14:30-a, VI, authorize the New Hampshire Department of Justice to retroactively amend FIS 22-063, approved by the Fiscal Committee of the General Court on February 18, 2022 and item #124, approved by the Governor and Executive Council on February 16, 2022, by extending the end date from June 30, 2023 to June 30, 2025 to accept and expend of \$215,366, from the U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance, BJA FY21 Comprehensive Opioid, Stimulant, and Substance Abuse Site-based Program (COSSAP), for the purpose of expanding and enhancing The Prevention, Enforcement, and Treatment Program (PET) effective upon approval of the Fiscal Committee of the General Court and Governor and Executive Council through June 30, 2025. 100% Federal Funds.

# **EXPLANATION**

This request is retroactive because the beginning date July 1, 2023 associated with this request is in the new biennium. It is the policy of the Fiscal Committee to act only on items within the current biennium and this is the first meeting in the new biennium. In February, 2022, the Fiscal Committee approved the use of this grant until June 30, 2023 and the Department wishes to continue with this grant funded program. This item was not budgeted because it is considered a discretionary grant and will not likely be awarded in subsequent years.

The New Hampshire Department of Justice is seeking authorization to accept and expend the remaining funds from the award, received from the U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance, BJA FY 21 Comprehensive Opioid, Stimulant, and Substance Abuse site-based Program (COSSAP).

COSSAP is specifically designed to help lower recidivism rates of overdose victims and provide support to families of those struggling with substance use disorder (SUD) through enhancing and expanding the PET program; mainly to fund dedicated police resources responding to overdose calls. The PET program identifies that police officers in New Hampshire are often the first, and sometimes only, responders to a scene where drugs are involved. Instead of treating the overdose situation as an investigation into criminal activity, officers can assist SUD users and affected family members by connecting them with needed resources. This program also identifies adverse childhood experiences (ACEs) to deter and prevent children from becoming future SUD users.

The PET program was created by the Laconia Police Department. With COSSAP funds, PET will expand to Belknap, Coos, Sullivan, Rockingham, Strafford, and Hillsborough Counties. Other enhancements to the PET program include partnering with Amoskeag Health and the Manchester Police Department to implement a whole-family approach to addressing the multigenerational cycle of substance misuse within a household through the ACEs Response Team (ACERT). The team includes a Manchester Police Officer, who provides training and information; an Amoskeag Health Family Advocate, who provides support and explain available victim services; and a Crisis Services Advocate, who gives support to prevent re-traumatization.

Additionally, funding provides for a program coordinator position from the Laconia Police Department. This position offers continuous trainings, resources, and support to police departments launching the PET program. The program coordinator will also assist with collecting data on project progress to satisfy Federal Performance Measures as required.

The New Hampshire Department of Justice is applying for Category 2 funding in the amount of \$4,710,993.00 under the Comprehensive Opioid, Stimulant, and Substance Abuse Site-based Program (COSSAP). This proposed program is statewide and includes partnerships with Amoskeag Health, Laconia, Belmont, Berlin, Claremont, Londonderry, Manchester, and Merrimack Police Departments. This project is designed to enhance and expand The Prevention, Enforcement, & Treatment Program (PET), which was started by the Laconia Police Department and Master Patrol Officer Eric Adams in 2015. This program was designed to help lower recidivism rates of overdose victims and provide support to families of those struggling with Substance Use Disorder (SUD). Dedicating a full time police officer to respond to all overdose calls in the city, Laconia was able to connect individuals and their family immediately to the few lifesaving resources available and with the success of the program; assisted in building more direct services to the area. This program includes enhancing PET in Laconia by not only expanding it to six other counties across the state, but also partnering with the Manchester Adverse Childhood Experiences Response Team Technical Assistance Center (ACERT TAC) to allow a multigenerational approach to SUD as New Hampshire was among the top ten states in the nation for drug overdose mortality rate in 2019. In October 2015, Manchester Police Department, Amoskeag Health and YWCA created the now nationally recognized ACERT to address trauma and facilitate the referral process of connecting families and children to mental health services following first responder intervention; by utilizing a multidisciplinary approach to meet immediate needs of children and families exposed to ACEs (adverse childhood experiences). The ACERT TAC will provide training and resources for the communities to ensure their networks of programs and services are trauma-informed. Immediate actions by responding law enforcement and access to needed resources for children with ACE's and adults with substance abuse can be instrumental in preventing future SUD. This project would integrate PET and ACE's into the first responders' curriculum

The PET program identifies that police officers in New Hampshire are often the first, and sometimes only, responders to a scene where drugs are involved. Instead of treating the overdose situation as an investigation into criminal activity, officers can assist SUD users and affected family members by connecting them with needed resources. This program also identifies adverse childhood experiences (ACEs) to deter and prevent children from becoming future SUD users.

The PET program was created by the Laconia Police Department. With COSSAP funds, PET will expand to Belknap, Coos, Sullivan, Rockingham, Strafford, and Hillsborough Counties.
