REQUESTED ACTION

1. Authorize the Department of Transportation to enter into a contract with R.S. Audley, Inc. (Vendor 154222) of Bow, NH, on the basis of a sole bid received of \$3,743,600, for railway-highway reconstruction in Wilton (Project: Wilton #42747), from the date of Governor and Council approval through October 25, 2024, unless amended by the Department in accordance with the Standard Specifications. 100% Federal Funds.

Funding is available in State Fiscal Years 2024 and 2025 as follows, with the ability to adjust encumbrances through the Budget Office between State Fiscal Years if needed and justified:

2. Further authorize that a contingency in the amount of \$187,180 be approved for payment of latent conditions, which may appear during the construction of the project. The contingency requested is 5% of the contract amount.

EXPLANATION

This project is part of the State's Ten-Year Transportation Improvement Plan, under the Railroad Crossings & Signals Program (RR-RCS). The project consists of two rail-highway reconstruction projects, crossing NH Route 31. Both crossings are owned by the State of New Hampshire and operated by Milford-Bennington Railroad.

Wilton 42747: The project is located at railroad crossing 844-302J at the intersection of NH Route 31/Burns Hill Road. Roadway construction work on NH Route 31 will extend approximately 100-ft south and 200-ft east. On Burns Hill Road work will extend approximately 200-ft west. Railroad track

construction will begin approximately 50-ft south and end 50-ft north of the crossing. Railroad improvements include installation of new pedestal signals, signal equipment, and replacement of the existing track structure across the intersection with concrete tubs. Roadway improvements include realignment of the NH Route 31/Burns Hill Road intersection, full depth pavement reconstruction within the limits of track improvement work, a concrete truck apron, new curbing and concrete islands, drainage, updates to sidewalk ramps, installation of updated signing and pavement markings, and installation of a Rectangular Rapid-Flashing Beacon System. This work has been coordinated closely with and supported by the Town officials.

<u>Wilton 43544:</u> This project is located at the railroad crossing 844-303R, on NH 31, approximately 450-ft west of Curtis Farm Road. The roadway construction work is anticipated to extend approximately 700-ft west and 200-ft east of the crossing. Railroad track construction will begin approximately 200-ft north and south of the crossing. Railroad improvements include installation of new signal pedestals, signal equipment, replacement of the existing track structure across NH Route 31 with concrete tubs, and underdrain improvements. Roadway improvements include proposed full depth pavement and new approach signage, guardrail, and pavement markings.

These projects are Railroad safety improvement projects, with the intent to improve safety for vehicular and rail traffic at each crossing.

The proposed contingency amount is 5% of the contract amount. This is to account for the risks associated with completing railroad improvements with work to existing railroad signal cabinets and connecting into existing rail from the rigid concrete track crossing.

Although the bid costs exceeded the Department's estimate by 36.95% the sole bid received is felt to be reasonable for the work involved. The major items that result in the higher bid were Item 692 Mobilization \$365,150, Item 690.3201 Modular Concrete Surface System \$ 182,000, Item 690.3202 Modular Concrete Surface System \$ 229,000 and Item 690.411 Welded Rail \$135,575. This is the third time this project was advertised. While higher than estimated, these cos are reflective of the complexity of coordination between roadway contractor and railroad sub-contractor and the relatively small quantities. The first bid was rejected for being too high, the second advertising resulted in no bidders. Readvertising this project would result, in our opinion, in higher prices and prevent the completion of the work in a timely manner. The Department considers it to be in the best interest of the State to accept this bid to accomplish these needed repairs.

The Contractor has been prequalified by this Department. The Contract has been approved by the Attorney General as to form and execution, and the Department has certified that the necessary funds are available and the bid reasonably conforms to the engineer's estimate in accordance with State procedure. Copies of the fully executed contract are on file at the Secretary of State's Office and the Department of

Administrative Service's Office, and subsequent to Governor and Council approval will be on file at the Department of Transportation.

This project funding is: 90% Federal funds (Railroad Crossings & Signals Program (RR-RCS)), with anticipated utilization of Turnpike Toll Credits for the State's 10% match, effectively using 100% Federal Funds.

A copy of the Tabulation of Bids received for this project is attached along with the Contract Supplemental Sheet and a map indicating the location of the project.

Your approval of this resolution is respectfully requested.

SUPPLEMENTAL PROJECT INFORMATION SHEET

DESCRIPTION: This contract consists of two rail-highway reconstruction projects, crossing NH Route 31. Both crossings are owned by the State of New Hampshire and operated by Milford-Bennington Railroad.

<u>Wilton 42747</u>: The project is located at railroad crossing 844-302J at the intersection of NH Route 31/Burns Hill Road. Roadway construction work on NH Route 31 will extend approximately 100-ft south and 200-ft east. On Burns Hill Road work will extend approximately 200-ft west. Railroad track construction will begin approximately 50-ft south and end 50-ft north of the crossing. Railroad improvements include installation of new pedestal signals, signal equipment, and replacement of the existing track structure across the intersection with concrete tubs. Roadway improvements include realignment of the NH Route 31/Burns Hill Road intersection, full depth pavement reconstruction within the limits of track improvement work, a concrete truck apron, new curbing and concrete islands, drainage, updates to sidewalk ramps, installation of updated signing and pavement markings, and installation of a Rectangular Rapid-Flashing Beacon System.

<u>Wilton 43544</u>: This project is located at the railroad crossing 844-303R, on NH 31, approximately 450-ft west of Curtis Farm Road. The roadway construction work is anticipated to extend approximately 700-ft west and 200-ft east of the crossing. Railroad track construction will begin approximately 200-ft north and south of the crossing. Railroad improvements include installation of new signal pedestals, signal equipment, replacement of the existing track structure across NH Route 31 with concrete tubs, and underdrain improvements. Roadway improvements include proposed full depth pavement and new approach signage, guardrail, and pavement markings.

FEDERAL FUNDING: <u>Wilton 42747 & Wilton 43544:</u> 90% (Railroad Crossings & Signals Program (RR-RCS)) utilizing Turnpike Toll credits as the State's 10% match.

CONTINGENCY: The proposed contingency amount is 5% of the contract amount. This is to account for the risks associated with completing railroad improvements with work to existing railroad signal cabinets and connecting into existing rail from the rigid concrete track crossing.

PROJECT INITIATED: Railroad Crossings & Signals Program (RR-RCS)

PROJECT EXPLANATION: These projects are Railroad safety improvement projects, with the intent to improve safety for vehicular and rail traffic at each crossing.


TRAFFIC IMPLICATION:

<u>Wilton 42747:</u> A one-time seven-day full roadway closure of the intersection will be required for the project. Vehicular detours will be in place for all approaches during the closure. During this roadway closure, the track will be closed for a one-time consecutive 72-hour period to complete the railroad track work. During the track closure, pedestrian traffic will also be closed. All other work will be completed with short-term one-lane, alternating two-way traffic.

<u>Wilton 43544:</u> To accommodate railroad reconstruction work, a 5-day track closure will be required for the project. This closure shall span over a weekend period and shall only impact the railroad's operations for a maximum of period of 72-hours. For final placement of the proposed rail system two (2) 30-minute road closures will be performed during one (1) nighttime period. All other work will be completed with short-term one-lane, alternating two-way traffic.


