## **REQUESTED ACTION**

In accordance with Administrative Rule Adm 611.08 (g), the Department of Natural and Cultural Resources, Division of Forests and Lands, Communication Operations Bureau, respectfully requests permission to increase their fleet size by two vehicles effective upon Governor and Executive Council approval.

## **EXPLANATION**

The Division of Forests and Lands has two new Forest Rangers positions included in the new biennium budget. These are first responder positions which are responsible for responding to wildfire incidents and law enforcement issues throughout the state. These positions require the use of emergency response vehicles which are also capable of transportation of fire supplies including pumps, chainsaws, fuel, hose and backpacks, and to tow heavy equipment, including prevention and Incident Command trailers to carry out the duties and responsibilities as assigned. Additionally, this position requires a vehicle equipped with the ability to travel off road to navigate the remote regions of the state and to transport personnel. For this reason, we are requesting approval for two additional fleet vehicles.

The Division of Forests and Lands is requesting a fleet increase by adding two  $\frac{1}{2}$  ton extended or crew cab 4wd pick up trucks. These pick-up trucks are necessary for the two additional forest ranger positions to fulfill the job requirements. One pick-up truck was ordered in January (PO 1090133), but not yet received and we plan to not surplus FL32 as this request was processed prior to the additional position. Funding for the second pick-up truck is available in account 03-035-035-351010-35050000-030-500300. Source of funds is 100% Other Funds (Agency Income).


The request to increase the fleet by two (2) pickup trucks is reasonably justified and compelling enough to merit consideration by the Governor and Executive Council in a near future meeting.
