#### **REQUESTED ACTION**

Authorize the Department of Health and Human Services, Division for Behavioral Health, Bureau of Mental Health Services, to provide four (4) organized meetings on the dates and at the locations stated in the table below, for a total cost not to exceed \$5,016.27, for the purpose of providing Youth Mental Health First Aid Training (MHFA) to a total of up to 120 non-State of New Hampshire employees, effective upon Governor and Council approval through July 30, 2024. 100% Federal funds.

#### EXPLANATION

The purpose of this request is to pay for meeting expenses incurred for the provision of Youth Mental Health First Aid (MHFA) training for the Department's Disaster Behavioral Health Response Team (DBHRT) trained volunteers and providers at Community Mental Health Centers (CMHC). These trainings are designed to help educate providers and DBHRT responders across the state who engage with youth experiencing a crisis.

Approximately 120 individuals from across the state will be trained in State Fiscal Year 2024.

In response to the increased national discourse around mass shootings, the Bipartisan Safer Communities Act (BSCA) (P.L. 117-159) provided funding to all states to strengthen and enhance mental health emergency preparedness and crisis response efforts. Funds must be spent on specific activities, including behavioral health crisis response trainings. The Department's Division for Behavioral Health and DBHRT collaborated to recommend these SAMHSA approved trainings.

Youth Mental Health First Aid training covers:

- Common signs and symptoms of mental health challenges in this age group, including anxiety, depression, eating disorders, and attention deficit hyperactive disorder (ADHD);
- Common signs and symptoms of substance use challenges and how to interact with a child or adolescent in crisis; and
- Expanded content on trauma, substance use, self-care, and the impact of social media and bullying.

Staff from NFI, Inc. will provide these trainings as part of their contract with the State of New Hampshire. The funds included in this request are for meeting expenses. The Department will continue monitoring NFI trainers' performance through the review of monthly status reports to ensure project deliverables and associated timelines are met and adhered to.

Should the Governor and Council not authorize this request, the Department may miss the opportunity to support effective responses to mental health and substance use problems in New Hampshire youth experiencing a crisis, therefore limiting the effectiveness of its community response preparedness, leading to continued high hospitalization rates, lengthier hospitalization and treatment waitlists, and gaps in community support for at-risk youth.
